The existing bridge is a single-span steel I-beam bridge and will be replaced with a wider precast concrete arch bridge on the same alignment. The project also includes associated roadway work on the bridge approaches. A combination of federal, state, and local funding will be used for this project.

Construction is anticipated to begin in late 2025 or early 2026 and will require a roadway closure. The 6.5-mile detour utilizes Germany Road, Lake Meade Road, Carlisle Pike (SR 94), and East Berlin Road (SR 234). The detour is shown below and also on the Township website.










LOCATION MAP
